Sir / Madam,

With reference to the above-cited subject, I am directed to inform you that, as per the procedure laid down by the University and your proposal for Conditional Continuation of Affiliation and/or Extension of Affiliation, the University is pleased to grant **Conditional Continuation of Affiliation and/or Extension of Affiliation** (in view of the above referred resolution of the Academic Council) for the **Academic Year 2026-27** under Sections 65(4), 68 and 69 of the Maharashtra University of Health Sciences Act, 1998, for the undergraduate course(s) of your college with the following intake capacity, subject to the permission granted by Central Government / National Commission for Homoeopathy / State Government (as applicable).

- BHMS (UG) – 70 Seats (reduced from 100)

The following deficiencies / conditions shall be complied with strictly within thirty (30) days from the date of receipt of this letter;

(i) Teaching Staff:

c. **Department of Surgery** – One Associate Professor is not available.

d. **Department of Community Medicine** – One Associate Professor is not available.

B. Hospital Functioning :-

a) 01 Surgeon is not available as per sub regulation C1(D) of the second schedule of National Commission for Homoeopathy (MES for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

b) 01 Gynecologist is not available as per sub regulation C1(E) of the second schedule of National Commission for Homoeopathy (MES for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

c) 01 Pathologist is not available as per sub regulation C1(G) of the second schedule of National Commission for Homoeopathy (MES for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

d) NABH/NABL accreditation certificate is not available required as per sub regulation A(3) of the second schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

C. Salary : Salary of teaching, non-teaching and hospital is not as per First Schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

The Shortcomings mentioned above as per reference No. 2 shall be fulfilled and copy of letter to be forwarded direct to the NCH, New Delhi with the copy to the University within a period of 30 Days.

(vi) Other:

- a. The college shall submit an Affidavit in the prescribed format as per Academic Council Resolution No. 229/2013 (format enclosed).
- b. For those UG/PG qualifications which are not yet recognized by the Central Government, the college shall mandatorily apply through the Central Government to the concerned Central Council/Commission and ensure that the qualifications presently shown as "Permitted" or "Not Recognized" are included in the list of Recognized Qualifications. Failing this, the University shall not grant Continuation of Affiliation for such courses from the ensuing academic year, and no student shall be admitted to such courses.

(vii) Settlement of University Dues:

"If your college fails to settle the advance amounts received from the University's Examination Department, Student Welfare Department, and other departments, or fails to submit the Utilization Certificate by 31/12/2026, punitive action shall be taken against your college or the continuation/extension of affiliation for the upcoming academic year 2027-28 will not be granted by the University."

(viii) Other Conditions:

- a. This Conditional Continuation/Extension of Affiliation is granted for the Academic Year 2026-27, subject to the permission of the Central Government / National Commission for Homoeopathy / State Government, as applicable. If such permission is refused by the competent authority, this Conditional Continuation/Extension of Affiliation shall automatically stand cancelled / infructuous. The college shall not admit any students to the First Year of the course until it receives the requisite permission from Central Government / National Commission for Homoeopathy / State Government.
- b. Admissions shall be made only through the Competent Authority.

(IX) IMPORTANT NOTES FOR STRICT ADHERANCE:

- a. The College shall comply with all the provisions of the Maharashtra University of Health Sciences Act, 1998, the Statutes, Ordinances, Regulations, Directions, and all applicable norms, regulations and guidelines issued by the concerned Central Council/Commission, the State Government and the University from time to time.
- b. Grant of Conditional Continuation/Extension of Affiliation for the Academic Year 2026-27 shall not confer any vested right upon the College to claim Continuation/Extension of Affiliation for subsequent academic years. Each proposal shall be considered independently in accordance with the prevailing statutory provisions and regulatory norms.
- c. The University reserves the right to conduct inspection(s) of the College and its attached teaching hospital at any time during the academic year to verify compliance with statutory provisions and regulatory norms.

d. Failure to rectify the deficiencies within the stipulated period shall render the College liable for appropriate action under the provisions of the MUHS Act, 1998, including withdrawal or refusal of Conditional Continuation/Extension of Affiliation, reduction of intake capacity or any other action deemed appropriate by the University.

e. If any information, declaration or document submitted by the College is found to be false, incorrect, misleading or suppressed at any stage, the Conditional Continuation/Extension of Affiliation granted under this order shall be liable to be withdrawn without prejudice to any other action permissible under law.

f. No student or institution shall claim any equity or special consideration on the basis of admissions made in violation of the provisions of this order or any applicable statutory provisions.
